CGAP Error Messages

The following table lists the Error messages that are generated in the current CGAP system based on the Pilot release. The final version of this will be a living document, which includes most of the errors in the Message Processing, Ticket Processing, Grant Application Processing and the business validation errors from the supplementary specification document. This is only a draft version and will be updated when the message is changed or new messages are added during development.
