



## ■ FSR (Financial Status Report)

- Replaces mainframe TSO system
- Search for grants based upon due date
- Submit new/revised FSR
- View FSR status (due, late, received etc.)
- Submitted FSRs appear in “Status”
- Integrates with NIH accounting system
- Over 15,300 FSRs processed (2,500 in Sep)
  - Over 9,500 from external users
  - Over 230 grantee organizations participating
  - Currently in full production (non mandatory)

## ■ IAR (Internet Assisted Review)

- Reviewers may
  - Electronically submit critiques and preliminary scores prior to the meeting
  - Review the critiques submitted by others on-line
  - Modify their critiques after the meeting
- SRAs may
  - Manage meetings and Reviewer's IAR access via Control Center
  - Designate applications as lower half (triage)
  - Download preliminary summary statements generated from submitted critiques
- 172 Review Meetings/6991 Applications so far
- 2,076 IAR accounts created
- 5,752 critiques uploaded
- Full production as of 8/1/2003 (not mandatory)

  - Improved interface and workflow
  - Additional 15 days allowed for submission
  - Delegated submission to PI possible
  - 353 eSNAPs submitted (299 Awards)
  - 21 grantee organizations participating  
(currently limited to CWG members and a few other pilot users)
  - Inclusion enrollment included in Aug release
  - Expanded deployment through Fall 2003
  - Full deployment Winter 2003/4 (??)


