TRANSITION TO ELECTRONIC SUBMISSIONS

- Distinction between submission and receipt dates will go away!
 - Submission by 8 p.m. Eastern time zone to Grants.gov.
 - For now verification within two business days of image posting on Commons (day posted does not count)
- Opportunity to spread out dates by mechanism or other metric

• • • CURRENT SCHEDULE

Uses calendar to spread work - Cycle 1:

- January 10: Ts
- February 1: New Rs, Ks, All Ps, Other (Gs, Ss, etc.)
- February 25: All AREA
- March 1: Resubmission, competing continuation, competing supplement Rs, Ks, Gs, Ss, etc.
- April 1: Small Business
- April 5: Fs
- o April 15: R13s/U13s
- May 1: All AIDS Applications (R13, R15, R41, R42, R43, R44, U13)

THE GREAT TAXONOMY DEBATE

Taxonomists are often divided into lumpers and splitters. *Lumpers* group organisms according to similarities in their features and *splitters* look for differences and create new classifications.

- January 25: All Ts
- February 1: All Ps; new R01s, new other Rs, Ss, Gs, etc.
- February 15: New R03s, R21s, Ks
- February 25: All AREA
- March 1: Resubmission/Type 2 & 3 R01s, other Rs, Ss, Gs, etc.
- March 15: Resubmission R03s, R21s; Resubmission/Type 2 & 3 Ks
- April 1: Small Business
- April 5: Fs

••• RATIONALE

- Large applications (Ps) early
- o Largest volume (R01s) early
- Try to give more time to newer investigators (Ks, R03s)

• • • ADVANTAGES

Spread out work for

- Investigators
- Institutions
- Grants.gov
- NIH (GrantsInfo, Exchange, Helpdesk, Referral)
- Shortens cycle a bit for some investigators

IDISADVANTAGES

• Nearly continuous submission dates

- Less downtime for other tasks for Offices of Sponsored Research at institutions
- Confusing for Principal Investigators submitting multiple applications
- Some readjustment of special dates for RFAs, PARs
- Complicates "window of consideration for late applications"
- Confusion Factor present system is confusing and this is more so
- Some investigators may perceive this as unfair – why do K applicants get longer than R01s?

CONFOUNDING CONSIDERATIONS

- Should a new scheme be implemented as transition to each mechanism or keep current schedule until full transition and then change?
 - Have already made the change for R15s
 - Pilot program for resubmissions of New Investigator R01s
- When fully electronic plan to shorten cycle, change dates by a month or more. Would it be better to keep current schedule until then and then change?
 - Initial efforts with Grants.gov may require more time to complete application, best to start early
 - Only one round of change
- Mixed approach (the NIH way flowers blooming!)
 - Change for some mechanisms at transition time R15s, Ts, etc.
 - Big changes/shortening when fully electronic
